**A SOLO II REGIONAL AUTOCROSS  
BROOKSVILLE, FL – SEPTEMBER 26-27, 2009**

**EVENT SITE:**

**Hernando County Airport – Brooksville, FL**

Located on U.S. Highway 41 between State Highways 50 and 52. Turn onto Runway Dr. off of U.S. 41. For a detailed, customized Google Map, go to: [Brooksville Site Map](#).

**From 50:** Travel South on U.S. 41 for 5.9 miles. Runway Dr. is on the right and just before a railroad crossing. **If you cross railroad tracks you have gone too far.**

**From 52:** Travel North on U.S. 41. Once entering Hernando County, you will pass a Hess Station on the left about 2.26 miles from Runway Dr. Continue until the North-bound lane splits into two lanes and you find a **railroad crossing**. Just after the **railroad tracks** a left turn lane will open that turns onto Runway Dr.

Once on Runway Dr., go straight to the gate where you will be checked in. **Past 9:00am, do not expect to gain entrance. When driving to the pits, observe and obey all signs. If there is a motorcycle school present, you must take the mowed path to the left around their area.**

**REGISTRATION:**

**ALL DRIVERS AND GUESTS must be on the access list by the deadline to enter the site. Drivers must pre-register and pre-pay online. Driver limit is 55 and guests 20. Guest registration is free, email FULL names to [asp1981@att.net](mailto:asp1981@att.net) Deadline is midnight Friday, Sept. 18. Follow this link to the registration calendar: <http://www.dlbracing.com/default.aspx>. Enter the Month (September), Year (2009), Club (SCCA Southeast Division), and Event (Autocross/Solo II) then find the event for Sept. 26-27 at Hernando County Airport and click on the "Register" icon to begin.**

\$25 - SCCA members and host site personnel per day  
\$40 - non-members (\$65 for the weekend)

**IMPORTANT INFORMATION:**

- **KEEP IT SLOW WHEN NOT ON COURSE BEFORE, DURING, AND AFTER THE EVENT.** An open runway is **NOT** an invitation to race. Violators will be banned from future events.

- **All drivers & passengers under 18 must have BOTH parents or legal guardians sign the minor waiver. One parent's signature is sufficient to allow the minor to be on site, but is not sufficient for the minor to be on the course as a driver or passenger.**

- **Numbers should be a minimum of 8" high and 1¼" stroke. Class letters should be 4" high. Numbers must be on the car before you go to tech! Blue tape may be used and will be available for \$5 per roll.**

- **Annual tech will be available to SCCA members. To get your car and helmet teched for 2009, you must have permanent magnetic or vinyl numbers.**

- Event conducted under the 2009 SCCA Solo II rules and CFR/SCCA Solo II Supplemental Regulations.

- Event is open to all licensed drivers.

- Event trophies will be distributed at the close of the competition event day.

- **SNELL 95** (or later) approved helmets are required; loaners are available. **DOT**-only helmets are **NOT** acceptable.

- Seat belts are required in all cars originally equipped with them. Vehicles must pass a basic safety inspection (battery securely mounted, no loose articles in car, tire tread acceptable and so on).

- Closed toed shoes only! No sandals or bare feet drivers.

- Mufflers are required on all cars. Sound limit is 98db at 75 feet.

- All entrants are required to work course assignments. Some work positions are available before and/or after the event. Contact the Event Chairman for details.

- No Nitrous Oxide Bottles allowed anywhere on site!
